Constanța , Romania, 21st – 24th of May 2024

Within the framework of the European Security and Defence College (ESDC), the Romanian National College of Home Affairs (CNAI) and the Naval Academy “Mircea cel Batran” (ANMB), will organise the course “*The Challenges of Securing Maritime Areas for the European Union*”, in Constanța, Romania, from 21 to 24 May 2024. The course will be supported by the Romanian Border Police and the Bulgarian Naval Academy “Nikola Y. Vaptsarov”, as course partners.

Participants from the EU Member States and relevant EU Institutions will be presented with the diplomatic, institutional, legal and operational issues related to the implementation of the Maritime Security Strategy of the European Union. The course will be organised on a residential basis, in Constanța (Romania) and will be anchored in practice, based on actual examples, case studies and practices in areas of strategic interest for the European Union and the Member States. The course will conclude with a complex exercise on the Black Sea, organised by the partners.

In the current context of increasing and widening threats at its borders, the European Union is aiming to strengthen its role in the field of maritime security, through the reinforcement of regional and international cooperation, by developing an integrated approach. Throughout the course, participants will benefit from an extensive networking framework and will get the opportunity to share views with fellow professionals on security and maritime issues, on the path to building an integrated *European security and defence culture*.

We are therefore very pleased to invite you to nominate suitable candidates to attend the ESDC training activity, which will offer the participants an excellent chance to create a network of practitioners working in the interrelated fields of maritime security within the EU Member States and institutions, building on the *European security culture*.

- **Target Audience:** The course is open to both civilian and military personnel. The EU Member States, EU Institutions and Agencies and the CSDP Missions and Operations are kindly invited to nominate each, one participant. However, more seats could be allocated, based on the total number of applications.
- **How to apply:** Applications are to be filed via the ESDC secure internet system ENLIST, by designated nominators, under <https://esdc.europa.eu/enlist/login>, no later than 26th April 2024. A list with relevant ENLIST nominators can be found on the ESDC website at <https://esdc.europa.eu/nominators/>.
- **Registration:** Registration will not be final until is confirmed by the ESDC Secretariat and upon completion of the requested personal data in ENLIST by the confirmed participants.
- **Language:** Working language is English, translation services will not be provided.
- **E-learning:** The course consists of an eLearning part done on the ESDC eLearning platform ILIAS, as well as a residential session held in Constanța, Romania, both parts being compulsory.
- **Attendance:** Attendance of the course is mandatory on all days. A certificate will be awarded to those course participants who will be completed the full course, including the eLearning phase.

The course starts on April 29th with the eLearning phase.

- **Location:** The residential part of the course will take place in Constanta, Romania from May 21th to 24th, 2024 and will be hosted by the Romanian Naval Academy “Mircea cel Bătrân” (address: 1st, Fulgerului Street, Constanța, 900218, Romania <https://www.anmb.ro>).
- **Cost:** All costs for travelling, accommodation and catering during the residential part of the course shall be covered by the sending authorities.

For your convenience, Hotel Pacific 3*** (<https://lira-pacific.ro>) is located just across the Naval Academy and no transfer should be applicable.

Participants are recommended to arrive to Bucharest (via Henri Coandă International Airport – Otopeni – IATA code BUH/OTP) or to Constanța (via Mihail Kogălniceanu International Airport Constanța) the latest on Monday, May 20th.. For transfer Bucharest to Constanța and way back, the participants are recommended to apply for online reservation on <https://alt-transportpersoane.ro/en>.

During the residential module the lunch will be optionally arranged on catering mode upon Naval Academy support on a cost of 25 RON (aprox. 5 euro) supported by the participants.

On May 23rd, Ministry of Internal Affairs will organize a Black Sea exercise to combat illegal migration involving ships and air support. Participants will be embarked on ships that will travel 4-5 miles on the Black Sea. The participants are required to wear an appropriate outfit for this type of outdoor activities.

After the exercise, on May 23rd at 18:00 a reception/official dinner will be offered to all course participants by the National College of Home Affairs. You are kindly invited to attend the reception, together with your course fellows, course organisers and lecturers.
